SJI PROVIDES LISTENING AND SPOKEN LANGUAGE INTERVENTION, AUDIOLOGIC MANAGEMENT, TODDLER CLASSROOM PROGRAMMING, AND FAMILY SUPPORT SERVICES. THROUGH A POWERFUL COMBINATION OF AUDIOLOGICAL SERVICES AND LISTENING AND SPOKEN LANGUAGE THERAPY, INFANTS AND THEIR FAMILIES ARE PROVIDED THE TOOLS THEY NEED TO HELP THEIR CHILD ACHIEVE TO THEIR FULLEST POTENTIAL. OUR THERAPISTS ARE LISTENING AND SPOKEN LANGUAGE (LSL) PROVIDERS THROUGH STATE-APPROVED PART C PROGRAMS. SERVICES ARE FAMILY-CENTERED, AND ROUTINE BASED.
